Do not approach or ride the pony/horse unless accompanied by a representative of Eddis Farm

Children must be supervised at all times.

No spooking the pony/horse. .

Only a Eddis Farm representative may lead or handle the pony/horse. Parents may assist in putting the children on the pony/horse if needed and are welcome to walk along side.

Eddis Farm, employees, and help are not responsible for any accidents or injuries

\_\_\_\_\_ Client has read and acknowledged all safety rules and guidelines provided to the client in the Pony Party Information document.

\_\_\_\_\_ You may arrive 30 minutes early to set up for the party. NO BALLOONS or NOISE MAKERS are allowed for the safety of the children, attendees, staff, and horses. \_\_\_\_\_ You understand that a ½ deposit is required to initially reserve your party date and time.

\_\_\_\_\_ You understand that the remaining balance must be paid in full no later than the day of your party .
